## Franchise Action Network Annual Meeting Recap

Last week, the International Franchise Association held a successful Franchise Action Network Annual Meeting in Washington, D.C. to help protect, promote, and enhance franchising. IFA advocated and advanced the most important franchise legislation in history, <u>H.R. 3441</u>, the Save Local Business Act.

With nearly 400 FANs attending Hill Day, IFA and the Franchise Action Network made considerable impact and even drew acknowledgement from Rep. Bobby Rush (D-IL), who submitted a resolution in the U.S. House, calling to designate September 13 as National Franchising Day in recognition of the massive contributions of the franchise business model and to honor those franchisees, franchisors, employees, and suppliers who make it one of the most powerful engines of economic growth in American history.

FANs from across the country traveled to Capitol Hill to meet with their members of Congress to discuss issues affecting their business, visiting Congressional offices of 38 states, 176 House districts, and 76 Senate districts. More than 75 of the meetings occurred with the member of Congress during a week of constant shuffling due to natural disasters, policy announcements, and Administration events. ## IFA Chair Addresses the Power of Women in Franchising and the Need for a Permanent Fix to Joint Employer

Last week, IFA Chair, Shelly Sun, penned an opinion piece in the Independent Journal Review urging the need for the passage of H.R. 3441, the Save Local Business Act. Sun demonstrates how franchising has been a successful engine for women to start their own business. However, with the joint employer issue hovering over the success of the franchise business model, the pressure remains. Delivering a compelling argument, Sun reiterated the need for a permanent solution. "This model (franchise) has empowered thousands of women throughout the country, including myself, and has put them on a path to achieve their dreams," said Shelly Sun.

#### Peter Robb Nominated for NLRB General Counsel

The Trump Administration officially announced the nomination of Peter Robb, a long time labor and employment attorney, for the role of General Counsel following the end of Richard Griffin's term on October 31. Robb worked as a field attorney in the NLRB's Baltimore office for three years. He then spent several years as a supervisory attorney with the Federal Labor Relations Authority. Robb also practiced at Proskauer Rose LLP for about ten years and is currently a

member of the American Bar Association's practice and procedures committee for the NLRB. If confirmed, he will be joining a Republican transition of the NLRB.

#### FAN at Work

U.S. House Rep. Scott Peters (D-CA) Visits Nothing Bundt Cakes in San Diego, CA

On Thursday, September 21, Rep. Scott Peters (D-CA) visited Mara Fortin's Nothing Bundt Cakes in San Diego, CA. Fixing the joint employer scheme was at the top of the agenda. The discussion also included other regulatory issues facing franchise business owners such as ADA drive-by lawsuits. Listening to the concerns of business owner, Mara Fortin, Rep. Peters recognized the burden of the regulatory onslaught on franchise businesses. The visit conduded as Mara urged the Congressman to support the new joint employer legislative fix, <u>H.R. 3441</u>, the Save Local Business Act, that would provide darity to the joint employer standard, restoring the "direct-control" definition under both the National Labor Relations Act and Fair Labor Standards Act.
